

**2017 - 18 HHS/BCHS STUDENT PARKING APPLICATION & POLICY**

Juniors and Seniors at Holmes and Business Careers High Schools may bring a personal vehicle on campus under the following conditions:

1. All vehicles must have a valid school parking decal affixed to the vehicle.
2. Students must have a state required license/permit and liability insurance **(student's name must appear on the insurance).**
3. Student must have a parking permit form completed and on file. **(there WILL be a \$15 fee)**
4. Student must be cleared of any school fines or fees.
5. Student should consult with the student handbook, read and adhere to section pertaining to the rules and regulations for parking on campus.
6. **CAMPUS PARKING**
  - a. Students **shall not** park in the area designated for administration, counselors or faculty
  - b. Students **shall not** park in "Visitor Parking Area".
  - c. Students **shall not** park behind the buildings, gym or athletic field area, tennis courts, or along the fence line.
  - d. Students **shall ONLY** park in student designated area. **Student parking is located in the parking lot adjacent to Ingram Rd., the Loop 410 Access Road, and behind the portables.**
7. Vehicles without parking decals will be ticketed on the second violation **(\$10)**

Parking privileges will be revoked for violation of the parking policies/terms of both Holmes/Business Careers High School. The school reserves the rights to inspect all vehicles with Canine Drug Detection Teams.

I understand that violating all or any of the above conditions could result in the loss of parking privileges at Holmes/Business Careers High School.
