2. Superintendent's Report

Dr. John Craft reported to the Board:

• Happy Veterans Day. Many events took place at campuses across the District to recognize Veterans Day. Dr. Craft attended a moving ceremony at Leon Springs ES. He thanked all veterans for their service and recognized Trustees Bobby Blount and David Salcido for their service.

• Bruce Hendin Fitness Fair at Ross MS. The Hendin Family was present at Ross MS to help host a community health event featuring various health screenings and vendors.

• Nellie Reddix Visit. Dr. Craft thanked Reddix Principal Robin Fields and the Reddix staff and students for hosting him. The visit was the highlight of his day.

• Bands March at Area Competition. All NISD high school marching bands advanced to the UIL Area Marching Contest this past Saturday, setting an Area H record with five of our 11 bands advancing to the final rounds. At the September 24, 2024, Board Meeting, a preliminary report was presented to the Board relative to the boundary changes from Bernal Middle School to Briscoe MS and Luna MS. The report included facts about Bernal to Briscoe and Luna Middle School, current school assignments, projected enrollment information, effect on sending and receiving schools and other pertinent considerations.

Subsequently, the report was presented to the School Boundary Advisory Committee (SBAC), which studied the administrative proposals and held two separate Public Hearings. The Public Hearings were held at Bernal MS on October 15 and at Luna MS on October 21, 2024.

The SBAC held a deliberation meeting on October 28, 2024, to discuss both boundary proposals. Following the

Boundary Deliberation, the SBAC members approved the attached recommendation.

Trustees heard the School Boundary Advisory Committee (SBAC) report regarding the proposal to move students from Bernal Middle School to Briscoe and Luna Middle Schools. Bernal is currently the largest middle school in the district with more than 1,600 students. The SBAC conducted a public hearing on Oct. 15 at Briscoe and Oct. 21 at Luna, and after listening to the public comments and reviewing all relevant data, made a formal recommendation to the Board regarding the attendance zones. Trustees voted to approve a variation of the formal recommendation to provide needed enrollment relief to Bernal MS.
