A Pre-Construction Conference will be scheduled at a date, time and location to be determined which will require attendance by you and all major Subcontractors working on this project site.

Once the Agreement is executed by both parties, a Notice to Proceed will be issued. We look forward to working with your company on this project.

Northside ISD Insurance Checklist

(Required by Article 11 of the NISD Supplementary Conditions to the AIA General Conditions)

Commercial General Liability (article 11.1.2.1.2)

- \$2,000,000 general aggregate;
 - \$1,000,000 products/completed operations aggregate;
 - \$1,000,000 personal and advertising injury;
 - \$1,000,000 each occurrence;
 - \$50,000 fire damage (Typically indicated as "Damage to Rented Premises");
 - \$5,000 medical expense.
- Policy issued upon an "occurrence" basis, as distinguished from a "claims" basis.

- * **Required endorsements:**
- Additional Insured.
 - Waiver of Subrogation.
 - 30-day notice of cancellation.

Automobile Liability (article 11.1.2.1.3)

- All vehicles (any auto) owned by, hired by or used on behalf of the Contractor, with minimum Combined Single Limit of \$1,000,000.

- Additional Insured.
 - Waiver of Subrogation.
 - 30-day notice of cancellation.

Umbrella Liability (article 11.1.2.1.5)

Insurance written on an occurrence basis, with minimum limits in the amount of:

Worker's Compensation (article 11.1.2.1.1): Statutory Limits required.

Employers' Liability (article 11.1.2.1.1)

- \$500,000 each accident;
- \$500,000 disease - policy limit;
- \$500,000 disease - each employee.
- If any Proprietor/Partner/Executive Officer/Member is excluded from coverage, describe under "Description of Operations" section of the Certificate.

- * **Required endorsements:**
- Waiver of Subrogation.
 - 30-day notice of cancellation.

Owner's and Contractor's Protective Liability Insurance * (article 11.1.2.1.4)

- Separate ACORD Form with Northside ISD indicated as the insured.
- General Contractor shall be named as the Certificate Holder.
- \$500,000 bodily injury
- \$500,000 property damage

- * **Required endorsements:**
- Waiver of Governmental Immunity.
 - 30-day notice of cancellation.

Builders Risk or Installation Floater Policy (article 11.3.1)

- Shall cover the entire Work at the site for the full insurable value of the Work, including transit thereto and materials stored offsite and destined to become a part of the Work.
- Maintained until final payment is made to the Contractor pursuant to Article 9 of NISD's Supplementary Conditions.
- No deductibles shall exceed \$5,000 without prior written approval of the Owner.
- The policy shall insure the respective interests of the Owner and the Contractor in the Work.

- * **Builders Risk Required Endorsements:**
- Permission to Occupy.
 - 30-day notice of cancellation.

- * **Installation Floater Required Endorsements:**
- 30-day notice of cancellation.
